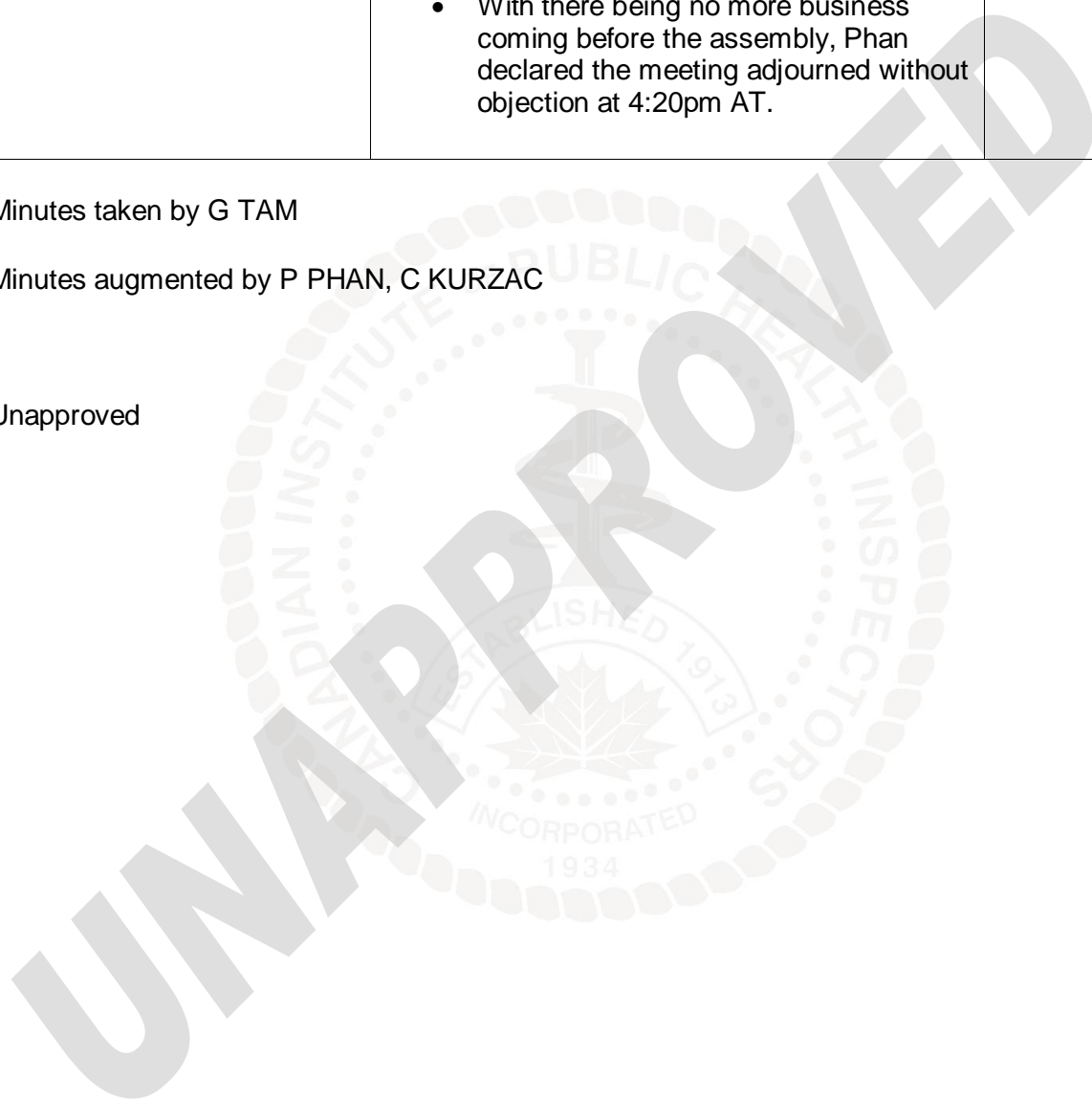

Convention Meeting Standing Rules

The following Rules of Order are designed to facilitate progress at the Annual General Meeting of the Assembly of the Canadian Institute of Public Health Inspectors, to include members in orderly debate and to ensure courtesy, fairness and equality for all:

1. The meeting will be conducted in accordance with The Canada Business Canada Corporations Act – Schedule 2, the Constitution and By-Laws of the association and Robert’s Rules of Order, Newly Revised.
2. This Annual General Meeting is for the purpose of transacting the business of the Canadian Institute of Public Health Inspectors. Issues of a personal nature will not be debated or considered.
3. All speakers will practice justice and courtesy at all times.
4. Members, who wish to speak, will wait to be recognized by the chair, and begin by stating their name each time they rise to speak.
5. No member may speak a second time, which includes asking a follow-up question, unless and until all those who desire to speak a first time, have had the opportunity to do so.
6. Comments or questions must be related to the pending motion or report.
7. Only one item, the immediately pending motion and/or the matter under discussion will be considered at a time.
8. Debate shall be limited to two (2) minutes for each speaker for each question
9. All ballots including the tellers reports shall be placed in the custody of the *Parliamentarian* to be retained until the conclusion of this Annual General Meeting, after which time, they will be destroyed if no election or voting issue has been contested.
10. Cell phones and pagers shall be silenced during the business meeting.

Appendix 3

CIPHI 2011 Annual Educational Conference Organizing Committee Report to the National Executive Committee June 24, 2011

Summary

Members of CIPHI's Nova Scotia/Prince Edward Island Branch made a motion at their 2008 annual general meeting to make a bid to host the 77th Annual Educational Conference in Halifax. With this motion passed, the membership began to organize a planning committee in March of 2009 to begin the process of making a bid to the NEC, and laying the foundation for a successful conference.

With the conference bid accepted at CIPHI's AGM in the spring of 2009, the planning committee began to meet on a regular basis to develop the team and explore educational and social opportunities for the conference. With collaboration being a key factor for success in our environmental public health programs in Nova Scotia and Prince Edward Island, the next logical step was to establish a conference theme centered on the concept of collaboration. "Strengthening Collaboration, Strengthening the Profession" was chosen as the conference theme and the committee began work to identify, discuss and confirm potential conference educational opportunities, social events, sponsors and exhibitors.

It is worth noting that early in its planning the organizing committee enlisted the assistance of Destination Halifax, an organization that promotes the city as a conferencing location. They were extremely valuable to us at all steps of the planning process from the initial bid package, to promoting the conference in Vancouver to current promotion of Halifax to our delegates.

Educational Program

The organizing committee strived to provide a diverse educational program, offered in three general streams which includes "Our Food", "Our Environment" and "Our Profession". Although the educational program follows the traditional format of past CIPHI conferences, the organizing committee wanted to incorporate technical tours as was done in Vancouver 2010 – providing an opportunity for delegates to learn in a more practical, "hands on" setting.

Social Opportunities

The opportunity to socialize and network are fundamental to the success of any CIPHI event and the organizing committee deliberated extensively on what social opportunities would provide the best forum for delegates to learn from each other through robust yet relaxed conversation. Taking advantage of the harbour setting and traditional east coast fair, the organizing committee settled on a lobster dinner, harbour cruise, maritime band and scenic tours as events to stimulate conversation and bring delegates together.

Sponsorship

The organizing committee reached far and wide to maximize potential sponsorship opportunities. All sponsorship levels are represented in Halifax, including platinum, gold, silver and bronze. Among these, Health Canada, Public Health Agency of Canada, National Collaborating Centres for Environmental Health, Infectious Disease and Methods and Tools, Orkin/PCO and the Province of Nova Scotia provided generous financial and in kind sponsorship to the conference. Many businesses and individuals contributed to the silent auction. The organizing committee succeeded in raising approximately \$70,000 in sponsorship support for the conference – this in the midst of significant budget restraint and cutbacks. This surpassed the organizing committee’s original goal of \$60,000.

Registration

At the time of this report, 241 delegates, exhibitors and speakers were registered for the conference. This exceeded the organizing committee estimate of 200 and is significant considering that we had reports of significant travel restrictions placed on Public Health Inspectors from jurisdictions across the country. Many of these registrations were confirmed in the final two weeks leading up to the conference.

Finance

The organizing committee is forecasting the following as of June 24, 2011:

Total Revenue	\$202,000
Total Expenses	\$167,000
Projected Profit	\$35,000

A more detailed financial report will be available post conference.

Lessons Learned

The organizing committee has, throughout the life of the committee, learned a lot about planning conference and the potential pitfalls CIPHI faces with such events. Among these is the expense of downtown locations during peak season (which ideally should be avoided), the lack of national corporate history and knowledge about the annual conference and coordination among CIPHI committees for meeting arrangements. These lessons learned will be reported in detail to the National Executive Committee as part of the organizing committee final report later in 2011.
