You are eligible to apply for The Professional Group Insurance Plan if, at the time of application:

1. You are resident in Canada.
2. You are under 61 years of age.
3. You qualify under one or more of the associations listed below.

You are eligible to apply for The Professional Extended Health & Dental Care Insurance Plan if, at the time of application:

1. You are resident in Canada and enrolled in a provincial health plan.
2. You are under 61 years of age.
3. You qualify under one or more of the associations listed below.
